

What is CodeMark™?

CodeMark™ is a new building product certification scheme for Australia and New Zealand. Third-party CodeMark™ certification bodies evaluate and certify products to ensure they meet specified requirements of the Building Code of Australia (BCA) and/or the New

Zealand Building Code (NZBC).

CodeMark[™] strengthens the entire building supply chain and gives users the confidence that their building products comply. Building materials, forms of construction and designs can come under the scheme.

Why CodeMark™?

Impressive benefits for everyone:

- Confidence legislated product acceptance by building control authorities¹ (product opinions, appraisals etc. do not have this legislated acceptance);
- · Confidence managing legal liability;
- Confidence operating in Australia and New Zealand, therefore increasing market potential and improving efficiency;
- Confidence for designers, architects, builders, building control authorities, consumers and others who specify, use, approve or invest in CodeMark™ certified products;
- Confidence underpinning the performance-based BCA and NZBC through facilitating the use of new and innovative products; and
- Confidence listing current CodeMark[™] certified products and accredited CodeMark[™] certification bodies in Australia at www.abcb.gov.au

Additional benefits for certificate holders:

- Confidence offering increased credibility and acceptance of a certificate holder's CodeMark™ certified products, whether established or new, therefore boosting consumer confidence in their organisation;
- Confidence entitling certificate holders to display the CodeMark™ "Mark of Conformity"; and
- Confidence introducing a choice of certification bodies, therefore encouraging a timely and cost effective service.

Additional benefits for certification bodies:

- Confidence providing accreditation from an internationally recognised accreditation body, therefore increasing credibility;
- Confidence increasing acceptance and credibility of a certification body's relevant product testing and evaluation methods; and
- Confidence entitling certification bodies to display the CodeMark™ "Mark of Conformity".

How does the CodeMark™ scheme work?


The Australian Building Codes Board (ABCB) and New Zealand's Department of Building and Housing (DBH) manage the scheme in their respective countries. The Joint Accreditation System of Australia and New Zealand (JAS-ANZ) accredits certification bodies, who in turn evaluate and certify building products. Relevant legislation requires building control authorities to accept CodeMark™ certified products¹.

¹ At the time of publication, some jurisdictions were yet to include provisions in their legislation to require building control authorities to accept CodeMark™ certified products, (provided they comply with the relevant CodeMark™ certificate including any conditions and limitations).

How can I get my product CodeMark™ certified?

Organisations seeking CodeMark™ certification for their product should apply directly to an appropriate CodeMark™ certification body. Accredited CodeMark™ certification bodies in Australia will be listed at www.abcb.gov.au

The requirements for evaluation and certification of products are set out in the CodeMark™ Scheme Rules, which are available from the ABCB. Any organisation that can satisfy an appropriate CodeMark™ certification body that its product meets these requirements can have its product CodeMark™ certified. Individual CodeMark™ certification bodies establish many of the finer matters, such as testing, fees, forms etc.

How can I become a CodeMark™ certification body?

Organisations wanting to become CodeMark™ certification bodies should apply directly to JAS-ANZ. The requirements for accreditation of CodeMark™ certification bodies are set out in the CodeMark™ Scheme Rules, which are available from the ABCB. Any organisation that can satisfy JAS-ANZ that it meets these requirements can become a CodeMark™ certification body.
